Dear All,

1. The Government of Nepal, Ministry of Urban Development, Department of Urban Development and Building Construction (hereinafter called "Borrower") has received financing from the International Development Association (IDA (the "Bank") in the form of a "credit" (hereinafter called credit toward the cost of *Nepal Urban Governance and Infrastructure Project (NUGIP)*). Triyuga Municipality, an implementing agency / Client, intends to apply a portion of the proceeds of this credit to eligible payments under the contract for which this Request for Proposals is issued. Payments by the Bank will be made only at the request of the Triyuga Municipality through PCO, NUGIP and upon approval by the Bank, and will be subject, in all respects, to the terms and conditions of the financing¹ agreement. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing.
